

**The Insiders' Natures' Bounty Campaign
Terms & Conditions
The Insiders – November 2023**

1. Promoter

1. The Campaign is run by “The Insiders UK”.

2. Campaign

1. Subject to these terms and conditions, members of The Insiders' community will be selected to participate in a campaign whereby upon selection to participate by The Insiders, if they purchase the specified Nature's Bounty product or multiple Nature's Bounty products after receiving an email with purchase instructions and selected product(s) they will receive a 100% refund at the end of the campaign.

3. Eligibility and application process

1. To participate in the Campaign, applicants must:

1. be 18 years or older;
2. reside in the United Kingdom and have an address in that country to which the products will be delivered to;
3. be a member of The Insiders community. Only one application to The Insiders community per household is permitted; and
4. make a Qualifying Purchase of the specified Nature's Bounty product(s) (see section 5 below).

2. Applicants fulfilling all of the above criteria may apply to participate in the Campaign by registering their interest on www.theinsidersnet.com.

3. By applying to take part in the Campaign, participants are agreeing to be bound by these terms and conditions.

4. Selection process

1. Selection of successful applications will be made by The Insiders and The Insiders' decision is both binding and final. Failure to be selected for this Campaign will have no bearing on any subsequent applications for, or participation in, other campaigns run by The Insiders.

2. Successful applicants (“**Participants**”) will be informed by email that they have been selected to participate in the Campaign. Unfortunately, we will not be able to contact unsuccessful applicants. **Please do not purchase any products to receive a refund unless you have been informed that you have been successful, and until you receive instructions to do so, as such purchase will not be eligible for the refund.**

5. How the Campaign Works

1. Some of the Participants will receive Nature's Bounty product(s) free of charge, they will receive an email from The Insiders to inform that they have been selected.

Making a Qualifying Purchase

2. The Insiders will contact some of the Participants by email informing them that they need to make a Qualifying Purchase of the specified Nature's Bounty product(s).

3. Only a Qualifying Purchase will be eligible for the 100% refund, subject to the remainder of this clause. The purchase of the Nature's Bounty product(s) will only be a Qualifying Purchase if all of the following conditions are met:

1. If the participant is selected for multiple products, they must purchase all of the specified products, in order to qualify for the refund.
2. the product(s) must be purchased through the specified retailer at the price available through that website. Purchases made from other retailers will not be eligible for the refund. Prices may vary according to the retailer's pricing changes. Purchases made using

vouchers, gift cards or any other alternative payment methods will not be eligible for the refund.

3. Participant must claim a spot in the campaign through a specific link and upload their proof of purchase and bank details to be included in the campaign. Participants purchasing multiple products must claim a spot and upload a proof of purchase for each product separately.

6. Campaign Actions

1. Participants are requested to do the following:
 1. write a product review of the Nature's Bounty product(s) and post to The Insiders website.
 2. post a review on various online retailer links.
 3. complete the end survey sent by The Insiders at the end of the Campaign.
